As the Tahoe region's oldest and largest community foundation, Parasol currently administers 153 charitable funds which supported 216 non-profit organizations. It is the intention of Parasol to continue to build charitable resources that will benefit the community now and into the future.

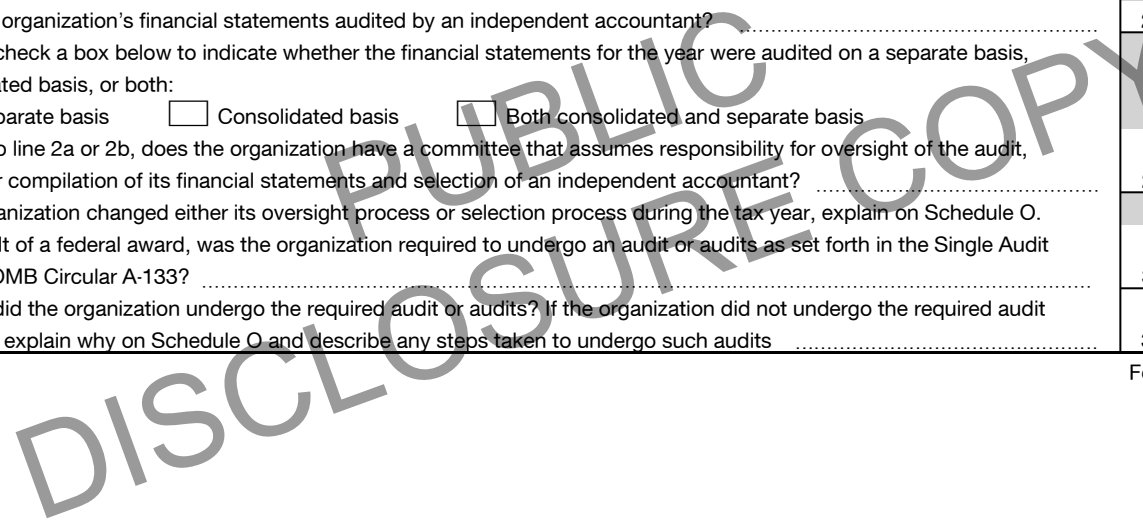
